

PRIVACY POLICY

Whitefield Management Kft (registered office: H-1204 Budapest, Mártírok útja 290., company registration number: 01-09-881579) (the Company) hereby informs visitors of the citizenpark.hu website about the personal data managed by it, its practice followed regarding the management of personal data, the measures taken to protect these personal data and, also about the rights of the parties concerned. This privacy policy is based on Act CXII of 2011 on Informational Self-Determination and Freedom of Information (hereinafter: the Privacy Act), and by way of this privacy policy, Whitefield Management Kft. complies with its obligation to provide prior information about the management of personal data, as stipulated in Section 20 of the Privacy Act.

Who manages my data, who is entitled to manage data and what is the address of the website of the controller?

Whitefield Management Kft (registered office: H-1204 Budapest, Mártírok útja 290., company registration number: 01-069-881579, e-mail address: info@whitefield.hu, address of the website of the controller: www.whitefield.hu, data management registration number: NAIH-121659/2017.) is both the controller (the party entitled to manage data) and the owner of the website.

Which of my data are processed?

- surname, first name
- e-mail address
- phone number
- cookie* (stored automatically when the website is visited)

*(The citizenpark.hu website operates an anonymous visitor ID (cookie). This is a unique string suitable for identification and the storage of profile information that service providers place on the computers of visitors. Having regard to the fact that the entire IP address is not stored during use, this string alone is by no means able to identify the client – that is, the visitor – ; it can only recognise the visitor's computer).

By registration and sending your request for proposal, you consent to the use of your data mentioned above for the purposes identified in this privacy policy.

What are the objectives of data management?

We will use your data primarily to enable that properties available on the website are to be purchased and customers expressing interest in using related services are contacted smoothly, and also to send you newsletters with special tailor-made proposals. We will use your data only to the extent necessary to reach these objectives. Furthermore, we use summarised and sanitized data to prepare statistics and statements. The controller ensures the security and the protection of data, including but not limited to preventing them from unauthorised access, alteration, transmission, disclosure, deletion, destruction, accidental destruction and damage, and from becoming inaccessible. In no case will we disclose data you provided to any third party.

What is the legal basis for data management?

The voluntary consent (Section 5 (1) of the Privacy Act) you grant us by finalising the registration and/or by sending the request for proposal.

How long are my data going to be managed?

Data management starts with your registration or by sending your request for proposal and encompasses a period of not more than 5 years. Obviously, you may unsubscribe from our newsletter at any time or request your data to be deleted from our database.

Who operates the website?

The website is operated by Whitefield Management Kft.

Who are entitled to get to know the data?

The controller and the controller's employees are entitled to get to know such data.

Which of my rights may I exercise with regard to data management?

You may access your personal data managed by Whitefield Management Kft. at any time and you may also request them to be amended or deleted.

Who can I contact in case of a complaint?

In case of a grievance regarding the management of your data, you may apply to the National Authority for Data Protection and Freedom of Information or bring an action before the general court having jurisdiction as per your domicile (place of residence).
